



RESOLUTION NUMBER R- 283031
ADOPTED ON NOV 29 1993

BE IT RESOLVED, by the Council of The City of San Diego that the bid of PIONEER PRIVATE SECURITY is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SECURITY GUARD SERVICE AT THREE OPERATIONS STATIONS, TWO MUNICIPAL AIRPORTS AND BALBOA PARK ADMINISTRATION BUILDING as may be required for a period of one (1) year beginning November 1, 1993 through October 31, 1994, per prices on file in the Purchasing Department, for a total estimated cost of \$355,446.00; cash discount terms 2% 21 days, with options to renew the contract for two (2) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 3%.

BE IT FURTHER RESOLVED, that in the event the contractor fails to perform in accordance with specifications, authorizing the Purchasing Agent to terminate the contract and award to the next low responsible and responsive bidder or to subsequent bidders, if necessary until a bidder is found who complies with specifications.
