BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. MARDEN SUSCO, INC., 2. DAVIS TAYLOR-JETT, 3. WESTERN WATER WORKS SUPPLY CO., 4. WESTBURNE PIPE & SUPPLY, and 5. PACIFIC PIPELINE SUPPLY are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing MISCELLANEOUS WATER SERVICE FITTINGS as may be required for a period of one (1) year beginning September 1, 1993 through August 31, 1994 per prices on file in the Purchasing Department as follows:

1. MARDEN SUSCO, INC. for Section A, with terms of 6% 20 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 10%.
2. DAVIS TAYLOR-JETT for Sections B & E, with terms of net 30, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with no option year price increases.
3. WESTERN WATER WORKS SUPPLY CO. for Section C, with terms of net 30 days, plus sales tax.
4. WESTBURNE PIPE & SUPPLY for Sections D & F, with terms of 2% 20 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with option year

price increases not to exceed the prices in effect for the previous contract period by more than 10%.

5. PACIFIC PIPELINE SUPPLY for Section G, with terms of 2% 20 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 6%.
