BE IT RESOLVED, by the Council of The City of San Diego that the bids of 1. COUNTY WHOLESALE ELECTRIC CO., 2. GRAYBAR ELECTRIC, 3. SUMMERS GROUP DBA ESD COMPANY, 4. COAST ELECTRIC SUPPLY, 5. SAN DIEGO WHOLESALE ELECTRIC COMPANY and 6. WESTINGHOUSE ELECTRIC SUPPLY CO. (WESCO) are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing WILL CALL SERVICE FOR THE PURCHASE OF ELECTRICAL PARTS, SUPPLIES AND EQUIPMENT as may be required for a period of one (1) year beginning October 1, 1993 through September 30, 1994 per prices on file in the Purchasing Department; with options to renew the contract for three (3) additional one (1) year periods, at the same discounts as follows:

1. COUNTY WHOLESALE ELECTRIC CO. for Sections 110, 140, 150, 170, 180, 210 and 270; terms 1% 20 days, plus sales tax.
2. GRAYBAR ELECTRIC for Sections 100, 110, 120, 130, 140, 150, 160, 170, 180, 190, 240, 260, and 270; terms net 30 days, plus sales tax.
3. SUMMERS GROUP DBA ESD COMPANY for Sections 100, 110, 120, 140, 150, 160, 170, 180, 190, 200, 210, 220, 250, 260, 270, 280, and 290; terms 2% 20 days, plus sales tax.

4. COAST ELECTRIC SUPPLY for Sections 100, 110, 120, 130, 140, 150, 160, 170, 190, 200, 220, 230, 250, 260, 270 and 290; terms 2% 31 days, plus sales tax.
5. SAN DIEGO WHOLESALE ELECTRIC COMPANY for Sections 100, 110, 120, 140, 150, 160, 170, 180, 190, 220, 230, 260, 270, 280, 290, and 300; terms 2% 20 days, plus sales tax.
6. WESTINGHOUSE ELECTRIC SUPPLY CO. (WESCO) for Sections 100, 110, 120, 130, 140, 150, 160, 170, 190, 230, 240, 250, 260, and 270; terms net 30 days, plus sales tax.
