

RESOLUTION NUMBER R- 283034
ADOPTED ON NOV 29 1993

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. MIRAMAR FORD SALES, INC. and 2. FULLER FORD meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of seventeen (17) DUMP TRUCKS as follows.

1. MIRAMAR FORD TRUCK SALES, INC. for Item 1 - eight (8) each 5 cubic yard dump truck (Ford F-800 equipped with a crysteel dump box and hoist) at a cost of \$39,649.00 each for a total cost of \$317,192.00; terms net 30 days, plus sales tax.

2. FULLER FORD for Item 2 - nine (9) each 3 cubic yard dump truck (Ford F-700 equipped with a crysteel dump box and hoist) at a cost of \$32,564.00 each for a total cost of \$293,076.00; terms 1% 20 days, plus sales tax with an option to purchase additional equipment for a period of six (6) months from the date of the original purchase order at the same cost and to renew contract for two (2) additional one (1) year periods with increases not to exceed 7% of the prices in effect in each prior period.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$ 657,563.77 from Fund Nos. 50033/50031, Department Nos. 8201/8203, Object Account No. 6013, and Job Order Nos. 88082/88092, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriated reserves.
