BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for RECONSTRUCTION OF PALM AVENUE - PHASE I.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$821,750.00, from CIP 52-512.0, PALM AVENUE - I-5 TO I-805 AND ADJACENT STREETS, Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs.
