
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

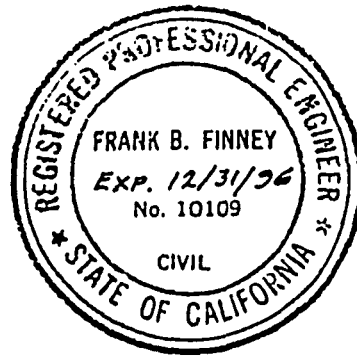

A RESOLUTION DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF SAN DIEGO, ON TUESDAY, NOVEMBER 2, 1993.

WHEREAS, a general municipal election was held in the city of San Diego on Tuesday, November 2, 1993; pursuant to the provisions of Ordinance No. 0-17948 (New Series) (adopted on August 2, 1993), for the purpose of electing candidates; and

WHEREAS, in accordance with San Diego City Charter section 12, paragraph 3, as amended by the voters on November 3, 1992, persons elected at the Municipal Primary and General Elections in 1993 to the positions of Councilmembers for Districts 1, 3, 5 and 7, are to serve a term of three (3) years; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the general municipal election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

The whole number of votes cast in the City was 93,783.

The total vote received by each municipal candidate at the general municipal election is as follows:

FOR COUNCIL DISTRICT NO. 1 (Three-year term):

HARRY MATHIS having received a majority of all votes cast is hereby declared elected to the office of Council District No. 1.

CHRISTINE KEHOE having received a majority of all votes cast is hereby declared elected to the office of Council District No. 3.

FRED H. COLBY 13,368

BARBARA WARDEN having received a majority of all votes cast is hereby declared elected to the office of Council District No. 5.
