BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay the total sum of \$69,300.00 (sixty-nine thousand three hundred dollars) in the settlement of each and every claim against The City of San Diego, its agents and employees, Superior Court Case No. 657459, Pacific Bell v. City of San Diego, resulting from damage which occurred to Pacific Bell's armored submarine cable running from Crown Point to the FAA Vector Island.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$69,300.00, made payable to Pacific Bell, in full settlement of the lawsuit and of all claims.
