RESOLUTION NUMBER R- 283073

ADOPTED ON NOV 29 1993

WHEREAS, the National Affordable Housing Act of 1990 requires that participating jurisdictions utilizing federal housing monies create a Comprehensive Housing Affordability Strategy (CHAS) to address affordable housing needs over a five-year period; and

WHEREAS, the City of San Diego is such a participating jurisdiction; and

WHEREAS, the City of San Diego's CHAS will need approval by the U.S. Department of Housing and Urban Development (HUD) in order for the City to remain eligible to receive certain federal housing funds; and

WHEREAS, the CHAS Federal Fiscal Year 1993 Performance Report has been prepared; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Comprehensive Housing Affordability Strategy covering the period of October 1, 1993, to September 30, 1998, on file in the office of the City Clerk as Document No. RR- 283073-1, is hereby approved.


2. That the CHAS Federal Fiscal Year 1993 Performance Report, a copy of which is on file in the office of the City Clerk as Document No. RR- 283073-2, is hereby approved.

3. That the Deputy City Manager is authorized to complete required CHAS Certifications of Fair Housing and Relocation, and submit the final City of San Diego's CHAS to HUD on behalf of the City.

4. That City staff and affiliated agencies are directed to pursue activities contained therein, as coordinated by the Housing Commission, including those which require presentation of policy recommendations to the City Council for consideration.
