RESOLUTION NUMBER R- 283078

ADOPTED ON NOV 29 1993

WHEREAS, the City of San Diego is engaged in a plan and program to upgrade its wastewater conveyance and treatment system known as the Consumers' Alternative; and

WHEREAS, the Consumers' Alternative calls for a water reclamation plant to be built in the northern part of the city and to be operational in 1997; and

WHEREAS, reuse of the reclaimed water from the North City Water Reclamation Plant will be both a valuable source of water and a valuable economic resource to the citizens of San Diego; and

WHEREAS, the City is exploring all methods of distributing the reclaimed water to ensure the best practical and economical manner of reuse. Said methods include exploring reuse through safe and sanitary mixing with the potable water supply as well as direct distribution to suitable users of reclaimed water; and

WHEREAS, the beneficial reuse of this water in whichever method is authorized will require construction of appropriate conduits; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is the intention of the Mayor and Council to construct the appropriate reclaimed water system consistent with sound economic principles; further, it is the intent to fund this

construction from the water rates as reclaimed water is a new source of water for water consumers. The ultimate cost of this system will depend on whether potable mixing is approved and pursued or whether direct distribution to reclaimed water users is approved and pursued.
