BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to require, for and on behalf of said City, all bidders hereafter bidding on City requirements of \$10,000.00 or more to certify that they are in compliance with Public Law 99-440 which prohibits importation of certain materials from South Africa.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to forbear making purchases from companies which have business operations in South Africa when such purchases are under \$500.00 in value and competitive bidding is not required, unless alternative sources of supply are not available.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to submit the question of additional prohibitions on the purchase of equipment and materials from South Africa to the Charter Review Panel for review and consideration.


