

RESOLUTION NUMBER R-283082

ADOPTED ON NOVEMBER 29, 1993

WHEREAS, the Park and Recreation Department was contacted in November 1991 by the AIDS Memorial Task Force regarding the establishment of a memorial in Balboa Park; and

WHEREAS, the AIDS Memorial Task Force, following a design competition, has now come forward with a concept proposal for a Living AIDS Memorial Garden to be located in the Cypress Point area of Balboa Park; and

WHEREAS, staff of the AIDS Memorial Task Force have held meetings with Park and Recreation staff regarding landscaping improvements at Cypress Point, with the Living AIDS Memorial Garden to be located east of Balboa Drive and south of Quince Street, to consist of tree groves and a paved sidewalk leading to an elevated grassy mound and encircled by crescent walls and additional landscape, with a number of fallen trees along and around the pathway; and

WHEREAS, based on a review of renderings and site plans, staff feels the proposed plan will be compatible with surrounding landscaping and other park uses and will not result in the loss of any significant assets; and


WHEREAS, the Park and Recreation Board reviewed the proposal at their meeting of October 21, 1993 and unanimously approved the project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council approves in concept a Living AIDS Memorial Garden in the Cypress Point area of Balboa Park.

BE IT FURTHER RESOLVED, that the Council hereby refers the details of establishment of a Living AIDS Memorial Garden to the Public Facilities and Recreation Committee for discussion in its January 12, 1994 meeting.
