30300, to CIP 52-489.0, WEST BERNARDO DRIVE - ANDANZA WAY TO I-15; and authorizing the expenditure of \$860,000.00 from CIP 52-489.0, WEST BERNARDO DRIVE, ANDANZA WAY TO I-15, (\$560,000.00 from Fund No. 30300, and \$300,000.00 from Fund No. 39056, for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
