RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, DECLARING THE RESULTS OF A "MELLO-ROOS COMMUNITY FACILITIES ACT OF 1982" SPECIAL ELECTION.

(Community Facilities District No. 1 [Miramar Ranch North])

WHEREAS, the Council of The City of San Diego, California, (the "Council") has previously declared its intention and held and conducted proceedings relating to alterations to the authorized facilities, to modify the existing rate and method of apportionment of the special taxes and to reduce the authorized bonded indebtedness in Community Facilities District No. 1 (Miramar Ranch North) (the "District"), as authorized pursuant to the terms and provisions of the "Mello-Roos Community Facilities Act of 1982" (the "Act"); and

WHEREAS, said Council did call for and order to be held an election to submit to the qualified electors of the District a proposition to approve the alteration of the types of authorized public facilities and the existing rate and method of apportionment of the special tax and the reduction of the authorized bonded indebtedness within the District; and

WHEREAS, at this time said election has been held and the measure voted upon did receive the favorable 2/3's vote of the qualified electors, and this Council does desire to declare the favorable results of the election in accordance with the


provisions of the Elections Code of the State of California; NOW,
THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego, as
follows:

1. That the above recitals are all true and correct.
2. That this Council hereby receives and approves the

submitted by the Election Official, said Statement setting forth
the number of votes cast in the election, the measure voted upon,
and the number of votes given for and/or against the measure

hereto, marked Exhibit "A," referenced and so incorporated.
3. That the City Clerk is hereby directed, pursuant to the
provisions of the Elections Code of the State of California, to
enter in the minutes the results of the election as set forth in
said STATEMENT OF VOTES CAST.
