

RESOLUTION NUMBER R-283100


ADOPTED ON NOVEMBER 30, 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is, hereby authorized to implement a seasonal weather shelter for ninety consecutive days at the Balboa Park Municipal Gym in accordance with the recommendations contained with City Manager's Report No. 93-336. However, the Manager's recommendation shall be revised as follows:

- 3) Discontinue the President's Way site as a designated feeding site, and report back in 30 days. The City Manager shall refer churches and other institutions to alternate sites. The City Manager is to work with churches to update the feeding program.
