RESOLUTION NUMBER R- 283102

ADOPTED ON DEC 06 1993

WHEREAS, the Point Loma Wastewater Treatment Plant commenced its initial operations in August of 1963 with treated effluent discharges through the Point Loma Outfall into the Pacific Ocean; and

WHEREAS, there has never been an instance of bacterial contamination occurring on any beaches due to the discharge of effluent from the original diffusers of the Point Loma Outfall; and

WHEREAS, in November 1983, the California State Ocean Plan was amended to include all kelp beds as body-contact areas, resulting in the application of bacterial standards that had previously been established and applied to bathing beaches; and

WHEREAS, in September 1990, the City completed engineering feasibility studies that indicated State Ocean Plan compliance could be achieved through extension of the existing Point Loma Outfall; and

WHEREAS, the U.S. District Court of Southern California on May 21, 1992 directed the City to achieve compliance with the State Ocean Plan by August 24, 1994 through an extension of the existing Point Loma Outfall; and

WHEREAS, the City Council by Resolution No. R-280005 adopted on June 1, 1992 awarded construction of the Point Loma Outfall extension contract to Point Loma Constructors, a joint venture; and

WHEREAS, on November 24, 1993, the project to extend the Point Loma Outfall 12,500 feet to seaward terminating 4½ miles offshore in a depth of 320 feet was completed, making this the longest, deepest, bottom laid reinforced concrete outfall in the world; and


WHEREAS, on November 24, 1993, the U.S. District Court was notified that this successful completion was accomplished over nine (9) months before the court deadline; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Point Loma Wastewater Treatment Plant is declared to be in full compliance with all aspects of the California State Ocean Plan.

BE IT FURTHER RESOLVED, that the Council extends its congratulations to all members of the Clean Water Program team involved in this difficult and demanding construction project.
