BE IT RESOLVED, that Resolution Number R-282601, adopted by the City Council on September 13, 1993, is hereby amended to allow an increased expenditure to two million five hundred and forty thousand dollars (\$2,540,000) from \$2.3 million in Fiscal Year 1994 from Police Federally Seized and Forfeited Assets funds

(Funds 18607, 10118, 10119) solely and exclusively for the purchase of two (2) helicopters plus related accessory equipment.
