WHEREAS, The City Council of The City of San Diego adopted Resolution Number R-282601 on September 13, 1993, authorizing the expenditure, not to exceed \$2.3 million in Fiscal Year 1994 from Federally Seized and Forfeited Assets funds (Funds 18607, 10118, and 10119) solely and exclusively for the purchase, or lease/purchase of two (2) helicopters plus related accessory equipment; and

WHEREAS, the actual expenditure required for the lease/purchase of two (2) helicopters plus related accessory equipment is two million five hundred and forty thousand dollars (\$2,540,000) in Fiscal Year 1994 from Police Federally Seized and Forfeited Assets funds (Funds 18607, 10118, and 10119); NOW, THEREFORE,

BE IT RESOLVED, that Resolution Number R-282601, adopted by the City Council on September 13, 1993, is hereby amended to allow an increased expenditure to two million five hundred and forty thousand dollars (\$2,540,000) from \$2.3 million in Fiscal Year 1994 from Police Federally Seized and Forfeited Assets funds

(Funds 18607, 10118, 10119) solely and exclusively for the purchase of two (2) helicopters plus related accessory equipment.
