BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF MIRA MESA BOULEVARD/MIRAMAR ROAD INTERCONNECT.

BE IT FURTHER RESOLVED, that the expenditure of \$639,000.00 from CIP 63-013.0, CONSTRUCTION OF MIRA MESA BOULEVARD/MIRAMAR ROAD TRAFFIC SIGNAL SYSTEM, State Grant Fund NO. 38513, is hereby authorized solely and exclusively for providing funds for said

project and related costs, and authorizing the Auditor and
Comptroller upon advice from the administering department, to
retain excess monies, if any, in CIP No. 63-013.0.
