
RESOLUTION NUMBER R- 283117

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of TRUST SERVICES OF AMERICA, INC., a California corporation, executed in favor of The City of San Diego, bearing date of March 12, 1991, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 283117, granting to said City an easement for public street purposes in a portion of Pueblo Lot 239, Miscellaneous Map No. 36, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named CAUBY STREET, RILEY STREET, and MIDWAY DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
