RESOLUTION NUMBER R- 283119

ADOPTED ON DEC 06 1993

WHEREAS, drivers and pedestrians impaired by alcohol and other drugs account for nearly 17,700 highway deaths annually; and

WHEREAS, motor vehicle collisions are the number one cause of death for children, adolescents, and young adults in the United States; and

WHEREAS, alcohol is involved in nearly half of all traffic fatalities; and

WHEREAS, injury and property damage resulting from impaired driving cause physical, emotional, and economic hardship for hundreds of thousands of adults and young people; and

WHEREAS, a decade of intense public education effort has proved that alcohol-related highway collisions are not accidents and can be prevented; and

WHEREAS, comprehensive community-based strategies to further reduce and prevent impaired driving tragedies are known; and

WHEREAS, if we take a stand now, we can prevent impaired driving; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council calls upon all citizens, government agencies, public and private institutions, businesses, hospitals and schools in The City of San Diego to promote awareness of causes of driver impairment, existing and proposed laws intended to

further reduce and prevent impaired driving, and opportunities to establish safer and healthier norms regarding the use of alcohol and other drugs for all citizens, particularly young people. .

BE IT FURTHER RESOLVED, that this city joins the hundreds of local, state, and national organizations in supporting efforts to reduce preventable traffic collisions on our roadways and hereby proclaims December 1993 to be "NATIONAL DRUNK AND DRUGGED DRIVING PREVENTION MONTH" in San Diego.
