BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to the cooperative agreement of June 29, 1992, with the San Diego Metropolitan Transit Development Board, to relocate water and sewer facilities as part of the Old Town Light Rail Transit Extension, under the terms and conditions set forth in the First Amendment on file in the office of the City Clerk as Document No. RR-283146, as well as any further amendments or modifications thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$84,793 from Water Fund 41500, Annual Allocation Water Main Replacement, CIP No. 73-083.0, is hereby authorized, solely and exclusively to provide funds for this amendment.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted water and sewer funds, of a minimum amount totaling \$45,364.00, to their respective project contingencies for use in Amendment No. 1.
