BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$80,000 (\$40,000 from Fund No. 102242, Object Account No. 4222 and \$40,000 from Fund No. 10226, Object Account No. 4222), is hereby authorized, solely and exclusively for the purpose of retaining the services of the above Law Firms.


