WHEREAS, a suggestion was made by Councilmember Ron Roberts to name the City parkade "The Evan V. Jones Parkade," to honor Mr. Jones for his service to the City of San Diego; and

WHEREAS, the matter was referred to the Public Facilities and Recreation Committee for further discussion and a recommendation and the Public Facilities and Recreation Committee has recommended in favor of the suggestion; and

WHEREAS, Mr. Jones founded Ace Parking Company in downtown San Diego in 1950 when he purchased a parking lot at 4th and B Streets; and

WHEREAS, under his guidance, the company has expanded its operations in the western United States and now operates 300 parking lots and employs over 2,000 people; and

WHEREAS, Mr. Jones, a native San Diegan, has been active in the parking profession and was one of the first presidents of National Parking Association; and

WHEREAS, Mr. Jones was instrumental in assisting the City in the development of the Administration Building, the Community Concourse, the Civic Theatre and the City parkade; and

WHEREAS, Mr. Jones' company was awarded the first contract to manage the parkade and his company continues to manage the parkade today; and

WHEREAS, Mr. Jones has also been very active in civic

organizations and was president of San Diego Chamber of Commerce, San Diego Museum of Art, San Diegans Inc., and Francis Parker School; and


WHEREAS, Mr. Jones has given his time freely to community boards such as Sharp Memorial Hospital, the Private Industry Council and Goodwill Industries; and

WHEREAS, as a token of the City's appreciation for his life long service to the San Diego community it is the recommendation of the City Manager and the Public Facilities and Recreation Committee to name the parkade "The Evan V. Jones Parkade;" NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City parkade located at First and A Streets is hereby named "The Evan V. Jones Parkade."
