BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager be and he is hereby directed to maintain a Business Registry for all City businesses on a cost recovery basis and return to the Council for implementation.
- 2. That the City Manager be and he is hereby directed to advise all new applicants for business licenses and all 50,698 of the City's existing license tax certificate holders upon license renewal that the City Council has eliminated the Business License Tax for Small Business beginning July 1, 1994 through June 30, 1995 in order to (1) stimulate economic growth; (2) encourage entrepreneurial activity; (3) help local businesses create new jobs; (4) reduce unemployment; and (5) help make San Diego one of the most business friendly cities in California.
- 3. That the City Attorney be and he is hereby directed to prepare an ordinance eliminating the Business License Tax for Small Businesses with twelve or less employees over two years from the current \$125 per business plus \$5 per employee, to: \$70

per business and \$3 per employee on July 1, 1994; to \$0 per business and \$0 per employee on July 1, 1995.
