ADOPTED ON DECEMBER 7, 1993

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A REPRESENTATIVE PROJECT
AREA COMMITTEE FOR THE COLLEGE COMMUNITY
REDEVELOPMENT PROJECT AREA.

WHEREAS, the Council of The City of San Diego (the
"Council") by Resolution No. R-280718, adopted the Procedure for
Formation of the Project Area Committee ("PAC") for the College
Community Redevelopment Project on September 22, 1992; and

WHEREAS, the Council by Resolution No. R-280894, approved
the PAC representatives initially elected to the PAC on
October 19, 1992; and

WHEREAS, since the initial September 30, 1992, election of
PAC members, vacancies have occurred on the PAC; and

WHEREAS, an Annual Meeting and Election of the PAC was
conducted on October 26, 1993, after notice and according to the
PAC bylaws and procedures enumerated within the documents
approved by the City Council, and a representative from the City
Clerk's office attended the October 26, 1993 election to ensure
its validity; and

WHEREAS, the newly elected members of the Project Area
Committee have submitted to this City Council information
establishing the qualifications of each person relative to
district, category, or organization as appropriate; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the College Community Redevelopment Project Area Committee consisting of the persons named on the list of Project Area Committee members receiving the highest number of votes on October 26, 1993 attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.

2. That the Council hereby concurs that the election results of October 26, 1993, are valid and binding in accordance with the procedures so adopted by Resolution No. R-280718.

3. That the Redevelopment Agency of The City of San Diego is hereby directed to consult with and obtain the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents of the Project Area for a period of three (3) years after adoption of the plan.
