That the City Manager is hereby authorized to execute a fifty-year Operating Agreement with the YMCA for the YMCA to construct, operate and maintain the Rancho Penasquitos YMCA facilities, under the terms and conditions set forth in that Operating Agreement on file in the office of the City Clerk as Document No. 00-18031-2.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING CHAPTER II. ARTICLE 2. DIVI-SION 9: OF THE BAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.0807. RELATING TO SALES OF REAL PROPERTY TO PUBLIC AGENCIES TO AUTHORIZE THE CITY ATTORNEY TO SETTLE EMINENT DOMAIN ACTIONS TO ACQUIRE CITY PROPERTY WITH A VALUE UP TO \$50,000.

This ordinance amends Chapter II, Article 2, Division 9, of the San Diego, Municipal, Code by amending section 22,0907, relating to sales of real property to public agencies to authorize the City Attorney to settle eminent domain actions to acquire City property with a value up to 550,000.
