AN ORDINANCE AMENDING ORDINANCE NO. O-17947 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1993-94 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17947-1, AS AMENDED AND ADOPTED THEREIN, BY INCREASING THE APPROPRIATIONS AND ESTIMATED REVENUES IN GENERAL FUND 100 BY \$362,000 FOR TRANSFER TO THE AUTOMATED CONTAINER FUND (10509).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. O-17947 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1993-94 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17947-1, as amended and adopted therein, by increasing the appropriations and estimated revenues in General Fund 100 by \$362,000 for transfer to the Automated Container Fund (10509), for the purpose of funding an automated refuse collection program in The City of San Diego.

Section 2. That the City Auditor and Comptroller be and he is hereby authorized to increase the estimated revenues and appropriations in General Fund 100 for the automated refuse collection program.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
