ORDINANCE NUMBER O- 18037 (NEW SERIES)

ADOPTED ON FEB 22 1994

AN ORDINANCE INCORPORATING 2.41 ACRES LOCATED AT 5150 MURPHY CANYON ROAD, IN THE KEARNY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM M-1B INTO THE CA-RR ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0427.1, AND REPEALING ORDINANCE NO. O-17842 (NEW SERIES), ADOPTED OCTOBER 19, 1992, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 2.41 acres, located 5150 at Murphy Canyon Road, in the Kearny Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-1B" on Zone Map Drawing No. B-4026, filed in the office of the City Clerk as Document No. 00-18037, is hereby incorporated into the CA-RR Zone, as such zone is described and defined by San Diego Municipal Code section 101.0427.1.


Section 2. That Ordinance No. O-17842 (New Series), adopted October 19, 1992, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
