BE IT FURTHER ORDAINED, that the expenditure of an amount not to exceed \$100,000 from Fund 79508, Peninsula Urban Impact Fees, is hereby authorized, solely and exclusively to reimburse the School District for the construction of improvements in accordance with the agreement.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
