ORDINANCE NUMBER O- 18052 (NEW SERIES)

ADOPTED ON APR 11 1994

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO MEMORANDA OF UNDERSTANDING WITH THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO (AGENCY) AND THE COUNTY OF SAN DIEGO (COUNTY) CONCERNING THE FINANCING, CONSTRUCTION, MAINTENANCE, AND OPERATION OF A NEW 900-BED, TYPE II, INMATE RECEPTION CENTER AND WITH THE COUNTY AND SHERIFF FOR THE COUNTY OF SAN DIEGO (SHERIFF) CONCERNING THE BOOKING PROTOCOL FOR CITY MISDEMEANANT ARRESTEES BOOKED IN THE INMATE RECEPTION CENTER.

WHEREAS, through negotiations between the City, Agency and County a plan has been developed for a 900-bed, 10-story, type II, Inmate Reception Center (IRC) on County property at Front and B Streets in the City of San Diego, just south of the City Operations Building; and

WHEREAS, the required project budget for this new facility, designed to meet the needs of the County and the City through the year 2010, is estimated at \$79.9 million; and

WHEREAS, the City Council, taking into consideration the above facts, and subject to the future budgeting of funds, desires to participate with the County and the Agency in the financing, construction, maintenance, and operation of a new 900-bed, type II, IRC in the downtown area of the City of San Diego and to enter a booking protocol signed by the City, County and Sheriff, for misdemeanor arrestees booked in the IRC; NOW, THEREFORE,

BE IT ORDAINED, that the City Council hereby authorizes the City Manager, on behalf of the City, to agree to and sign the Memorandum of Understanding between the City of San Diego (City), Redevelopment Agency of the City of San Diego (Agency) and the County of San Diego (County), concerning the financing, construction, maintenance, and operation of a proposed new 900-bed, type II, Inmate Reception Center (IRC), and the Memorandum of Understanding between the City of San Diego (City), the County of San Diego (County) and the Sheriff for the County of San Diego (Sheriff) concerning the proposed booking protocol for City misdemeanor arrestees booked in the IRC, under the terms and conditions set forth in the Memoranda of Understanding on file in the Office of the City Clerk as Document No. OO- 18052.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
