AN ORDINANCE WAIVING PROVISIONS OF SAN DIEGO MUNICIPAL CODE SECTION 62.0208 PERTAINING TO THE SKYLINE PARK COST REIMBURSEMENT DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the provisions of San Diego Municipal Code section 62.0208 which require that the district be formed before the construction is completed shall not be applicable to the Skyline Park Cost Reimbursement District.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
