Section 1. That Chapter X, Article 3, Division 7, of the San Diego Municipal Code be and the same is hereby amended by amending Section 103.0702, to read as follows:

**SEC. 103.0702 Boundaries**

The regulations which follow shall apply in the Golden Hill Planned District which is within the boundaries of the Golden Hill community planning area in the City of San Diego, California, designated on that certain Map No. C-864, and described in the appended boundary description filed in the office of the City Clerk under Document No. 00- 18054.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
