BE IT ORDAINED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an Agreement for Joint Use and Maintenance of Property Acquired for Expansion of Washington Elementary School Site (the "Agreement") for the operation and maintenance of recreation facilities at Washington Elementary School, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. OO- 18059

BE IT FURTHER ORDAINED, that the Agreement shall expire when title to the expansion property is conveyed to the San Diego Unified School District as described in paragraph 5.5 of the First Amendment to Cooperation Agreement which is on file in the office of the City Clerk as Document No. RR- 283638.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
