AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 44.0322 RELATING TO DOG LICENSE FEES.

WHEREAS, the City Manager issued Report No. 94-183 with recommendations concerning animal control services in The City of San Diego; and

WHEREAS, one of the recommendations was to remove the additional unaltered license fee of \$0.50 per year presently being used to establish a low cost spay/neuter program in The City of San Diego; and

WHEREAS, the City Council wishes to establish in the San Diego Municipal Code the dog license fees to be charged in the City of San Diego effective September 1, 1994; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IV, Article 4, of the San Diego Municipal Code be and the same is hereby amended by amending section 44.0322 to read as follows:

**SEC. 44.0322 DOG LICENSE FEES**
