ORDINANCE NUMBER O- **18100** (NEW SERIES)

ADOPTED ON **SEP 12 1994**

AN ORDINANCE INCORPORATING 7.60 ACRES LOCATED AT 7750-7790 MIRAMAR ROAD, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE M-1B ZONE INTO THE CC (COMMUNITY COMMERCIAL) ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0427, AND REPEALING ORDINANCE NO. O-15039 (NEW SERIES), ADOPTED OCTOBER 15, 1979, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That that certain parcel containing 7.60 acres, located at 7750-7790 Miramar Road, in the Mira Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M1-B" on Zone Map Drawing No. B-4035, filed in the office of the City Clerk as Document No. 00-18100, be, and it is hereby incorporated into the CC (Community Commercial) Zone, as such zone is described and defined by San Diego Municipal Code section 101.0427.

Section 2. That Ordinance No. O-15039 (New Series), adopted October 15, 1979, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this
