AN ORDINANCE AMENDING CHAPTER V, ARTICLE 5, DIVISION 8, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTION 55.0889.0101 AND AMENDING SECTION 55.0101.0001 RELATING TO THE UNIFORM FIRE CODE REGARDING LIFE SAFETY REQUIREMENTS FOR EXISTING BUILDINGS OTHER THAN HIGH-RISE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 5, Division 8, of the San Diego Municipal Code be and the same is hereby amended by repealing section 55.0889.0101 relating to Life Safety Requirements for Existing Buildings other than High-Rise.

Section 2. That Chapter V, Article 5, Division 8, of the San Diego Municipal Code be and the same is hereby amended by amending section 55.0101.0001(h), to read as follows:

**Sec. 55.0101.0001 Adoption of the Uniform Fire Code, 1991 Edition, Purpose and Intent, and Administrative Provisions**

No change in subsections (a) through (g).


