AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3, DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE BY CHANGING THE NAME OF THE NORTH CITY WEST PLANNED DISTRICT TO THE CARMEL VALLEY PLANNED DISTRICT AND BY AMENDING SECTION 103.0602 RELATING TO THE AREA OF APPLICABILITY BY INCORPORATING THE AREA IDENTIFIED ON ZONE MAP DRAWING NO. B-4046.1 INTO THE A-1-10, SF2, SF3, MF1, NC, EP AND OS ZONES AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 103.0608 THROUGH 103.0611, 103.0614 AND 103.0619 AND REPEALING ORDINANCE NOS. 9030 (NEW SERIES), ADOPTED JUNE 4, 1964; 10262 (NEW SERIES), ADOPTED APRIL 7, 1970; 10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972; 12658 (NEW SERIES), ADOPTED MAY 22, 1979; 12659 (NEW SERIES), ADOPTED MAY 22, 1979; AND 12660 (NEW SERIES), ADOPTED MAY 22, 1979, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the name "North City West Planned District" identified in Municipal Code Sections 103.0600 through 103.0620 be changed to the "Carmel Valley Planned District" to correspond with prior action of the Council of The City of San Diego on February 4, 1991, renaming the community of North City West to Carmel Valley.

Section 2. That the boundaries of the North City West Planned District (Carmel Valley Planned District) be expanded to include those properties shown on Zone Map Drawing No. B-4046.1.

Section 3. That the Neighborhood 10 Precise Plan area,

located in the Carmel Valley Community Plan area, in the City of San Diego, California, within the boundary of the district designated A-1-10, SF2, SF3, MF1, NC, EP and OS on Zone Map Drawing No. B-4046.1, filed in the office of the City Clerk as Document No. OO-18102 , be, and it is hereby incorporated into the A-1-10, SF2, SF3, MF1, NC, EP and OS Zones, as such zones are described and defined by San Diego Municipal Code sections 103.0608 through 103.0611, 103.0614 and 103.0619.

Section 4. That Ordinance Nos. 9030 (New Series), adopted June 4, 1964; 10262 (New Series), adopted April 7, 1970; 10936 (New Series), adopted October 5, 1972; 12658 (New Series), adopted May 22, 1979; 12659 (New Series), adopted May 22, 1979; and 12660 (New Series), adopted May 22, 1979, of the ordinances of the City of San Diego, be and are hereby repealed insofar as the same conflict herewith.

Section 5. In areas of the City of San Diego other than the Coastal Zone, no permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of the adoption of this ordinance.

Section 6. Within the Coastal Zone no permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date the California Coastal Commission unconditionally certified this ordinance as a local coastal program amendment.

Section 7. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
