AN ORDINANCE AMENDING CHAPTER VIII,  
ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY  
AMENDING SECTION 86.01 RELATING TO PARKING  
ENFORCEMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 86.01.


**SEC. 86.01 Nonenforcement Days**

The parking meter and time restrictions imposed under or pursuant to the authority of this Article shall not apply on Sundays, or upon the calendar dates on which New Year's Day, Martin Luther King, Jr.'s Birthday, Presidents' Day, Memorial Day, Independence Day, Labor Day, Veteran's Day, Thanksgiving Day, and Christmas Day are celebrated. The City Council may however, by resolution or ordinance, prohibit or limit parking on any street during all or certain hours of any such day and such limitation or prohibition shall be effective only when appropriate signs giving adequate notice thereof are erected or placed upon such street.

Section 2. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
