AN ORDINANCE INCORPORATING .83 ACRES LOCATED SOUTH OF UNIVERSITY AVENUE, NORTH OF ROBINSON AVENUE, EAST OF SEVENTH AVENUE AND WEST OF INTERSTATE HIGHWAY 163, IN THE MID-CITY COMMUNITIES PLANNED DISTRICT WITHIN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE NP-1 INTO THE CN-1A ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 103.1507, AND REPEALING ORDINANCE NO. O-17306 (NEW SERIES), ADOPTED MAY 30, 1989, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That .83 acres, located between University

Avenue, Robinson Avenue, Seventh Avenue and Interstate Highway

163 and described as Lots 9 through 12 Block 6, Portion of Tract

Crittenden's Addition, Map 1375 (.32 Acres), Lots 25-28, Block 6,

Crittenden's Addition, Map 889 (.30 Acres) and Lot 12, Block 1,

La Canyada Villa Tract, Map 1005 in the City and County of San

Diego, in the Uptown Community Plan area, in the City of San

Diego, California, within the boundary of the district designated

"NP-1" on Zone Map Drawing No. C-868, filed in the office of the

City Clerk as Document No. 00-18115, be and it is hereby incorporated into the CN-1A zone, as such zone is described and defined by San Diego Municipal Code section 103.1507.

Section 2. That Ordinance No. 0-17306 (New Series), adopted May 30, 1989, of the ordinances of The City of San Diego be and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
