AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3, DIVISION 15, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 103.1502 RELATING TO THE MID-CITY COMMUNITIES PLANNED DISTRICT
