WHEREAS, The City of San Diego, by Resolution No. 158360, adopted December 17, 1959, authorized the City Manager to execute a Lease Agreement with the United States of America for a portion of the Miramar Sanitary Fill, a copy of which lease agreement is on file in the office of the City Clerk as Document No. 605368; and

WHEREAS, under the provisions of the agreement, the City agreed to restore the premises to a clean and orderly condition prior to the termination date, October 26, 1974, including the construction of proper drainage, dressing of slopes and removal of fences; and

WHEREAS, an unsuccessful search was made for excess spoil dirt to complete the restoration of the area and the City must generate cover dirt at the landfill site; and

WHEREAS, said restoration is expected to extend past the termination date of the agreement and it is now desirable to extend the above mentioned lease agreement through June 26, 1975, under the same terms and conditions as originally agreed to by and between the parties; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to execute a document, the form of which is on file in the office of the City Clerk as Document No. 747710, extending the term of said lease agreement from October 26, 1974 through June 26, 1975, on a month to month basis, under the same terms and conditions as
