

**RESOLUTION No.** R-259986 (R-84-1090 )

Adopted on JAN 23 1984

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. THE O'BRIEN CORP. (FULLER O'BRIEN PAINT), 2. FINE LINE PAINT CORP. and 3. PPG INDUSTRIES are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of PAINTS AND COATINGS as may be required for a period of one (1) year beginning January 1, 1984 through December 31, 1984, per prices on file in the Purchasing Department as follows:

1. THE O'BRIEN CORP. (FULLER O'BRIEN PAINT) for Items 1 and 4; terms 1% 10th prox., plus sales tax, with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 8% of bid prices.
2. FINE LINE PAINT CORP. for Items 2, 3, 5, 7, 8 and 9; terms 2% 10 days, plus sales tax; with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 10% of bid prices.
3. PPG INDUSTRIES for Item 6; terms 2% 10th prox., plus sales tax; with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 8% of bid prices.
