WHEREAS, an agreement between The City of San Diego and the Natural History Museum was approved by the City Council by Resolution No. R-281699 on March 29, 1993; and

WHEREAS, upgrades are necessary to bring the facility into compliance with the City's fire/life safety requirements; and

WHEREAS, the Museum is prepared to begin construction of the facility's HVAC improvements and has initiated the upgrade of its seismic resistance; and

WHEREAS, those components of the project have been partially funded in the amount of \$489,922 from Certificates of Participation Balboa Park and Mission Bay Park Projects, Phase IA, with the balance of \$1,765,340 to be funded from Phase IB; and

WHEREAS, the Balboa Park/Mission Bay Park Certificates of Participation, Phase IB proceeds were received on November 30, 1993 and are available to reimburse the Natural History Museum according to the terms of the previously approved agreement, on file in the office of the City Clerk as Document No. RR-281699; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of the amount of one million seven hundred sixty-five thousand, three hundred forty dollars (\$1,765,340) from CIP 21-834.0, "Balboa Park/Mission Bay Park Certificates of

Participation, Phase IB Proceeds," into San Diego Facilities and Equipment Leasing Corporation Fund 91101, is hereby authorized to reimburse the Natural History Museum for building improvements.
