WHEREAS, the renewal of the third option year is based upon the contractor's above standard performance during the past year; NOW, THEREFORE,

that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with LUTH & TURLEY, INC., for general reconstructive contracting and cleanup work for damages to private property as outlined in Council Policy (400-10) and for those property damages for which the City may be responsible, under the terms and conditions set forth in the Agreement beginning February 1, 1994 through January 31, 1995, on file in the office of the City Clerk as Document No. RR- 277266, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$700,000 consisting of \$363,300 from the Water Utilities Water Fund 41500 and \$336,700 from Sewer Fund 41506, is

hereby authorized, solely and exclusively for the purpose of providing funds for the above contract.
