
ADOPTED ON JAN 18 1994

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$145,000 from Fund 41200, Dept. 751, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
