BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$85,804.66 from Fund No. 100, Department No. 443, Organization No. 650/750, Object Account No. 6010, and Job Order Nos. 044365/044375, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
