RESOLUTION TO SUPPORT LIGHT RAIL TRANSIT
SERVICE TO THE SAN DIEGO JACK MURPHY STADIUM
PRIOR TO THE 1998 SUPER BOWL.

WHEREAS, The City of San Diego has been selected to host the 1998 Super Bowl on January 25, 1998 at San Diego Jack Murphy Stadium; and

WHEREAS, the Metropolitan Transit Development Board (MTDB) has a Regional Rail Transit Plan for implementation of a light rail transit (LRT) system; and

WHEREAS, MTDB is currently constructing an LRT extension from Centre City San Diego to Old Town; and

WHEREAS, MTDB is designing another LRT extension from Old Town through Mission Valley to the San Diego Jack Murphy Stadium; and

WHEREAS, certain City of San Diego parcels of land will be required for LRT rights-of-way; and

WHEREAS, MTDB is appraising and acquiring both public and private property for LRT rights-of way; and

WHEREAS, the LRT plans will be reviewed by The City of San Diego at various design and construction phases; and

WHEREAS, the construction of the Mission Valley West LRT Project is necessary for the balanced transportation access to the Stadium; and

WHEREAS, LRT construction work on public lands, including the Stadium will need to be expedited, possibly with overtime by MTDB and the contractor; and

WHEREAS, the Metropolitan Transit Development Board of Directors directed the MTDB General Manager to expedite the Old Town LRT Project and the Mission Valley West LRT Project so that LRT service will be operational from Centre City San Diego to the San Diego Jack Murphy Stadium by October 1997, in sufficient time for the Super Bowl in January 1998; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the Council:

1. supports the timely completion of LRT service from Centre City to the San Diego Jack Murphy Stadium in sufficient time for the Super Bowl in January 1998;
2. directs the City Manager and the San Diego Jack Murphy Stadium Authority to continue to coordinate with MTDB on the Old Town LRT Project and the Mission Valley West LRT Project and provide timely reviews, approvals, and right-of-way dedications for MTDB;
3. encourages property owners, residents, and developers in Mission Valley to cooperate with MTDB on the development of

the LRT project in regard to design, right-of-way dedications, acquisitions, and constructions.
