A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REPROGRAMMING AND TRANSFERRING FISCAL YEAR 1994 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS TO THE REDEVELOPMENT AGENCY.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That \$150,000 in Fiscal Year 1994 Community Development Block Grant ("CDBG") funds previously allocated to the following three CDBG projects be reprogrammed and transferred to the Redevelopment Agency of The City of San Diego ("Agency") for use in the "Home in the Heights" Project of the City Heights Redevelopment Project (Fund 98200): \$70,000 from Fund 18529, Department 4049, Organization 4916; \$75,000 from Fund 18529, Department 4049, Organization 4915; and \$5,000 from Fund 18529, Department 4049, Organization 4914.
- That the Auditor and Comptroller be and he is directed to record the above disbursements to the Agency as interest bearing loans, and such loans shall accrue interest as calculated by the City Auditor and Comptroller, to be repaid from tax increment or other revenues.
- 3. That in the event the Agency issues bonds, notes, refunding bonds or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge or tax

increment allocation received by the Agency pursuant to California Health and Safety Code section 33670; and any indebtedness of the Agency to the City, including any interest accrued thereon shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
