- KEARNY MESA FORD for Item 1 one (1) off-road enforcement 1. vehicle (Ford Bronco XL) at a cost of \$19,016.00, Item 3 four (4) Cargo Vans (Ford E-150) at a cost of \$13,596.00 each, Item 4 - three (3) shop trucks (Ford F-150) at a cost of \$12,549.00 each, and <a>Item 5</a> - three (3) shop trucks (Ford Ranger XL) at a cost of \$10,364.00 each, for a total cost combined cost of \$142,139.00; terms net 30 days, plus sales tax, less trade-in allowances.
- TUTTLE-CLICK FORD for <a>Item</a> 2 two (2) off-road enforcement 2. vehicles (Ford Bronco XL) at a cost of \$19,074.75 each, for a total combined cost \$38,149.50; terms net 30 days, plus sales tax, less trade-in allowances.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$146,710.86 from Fund No. 100, Dept. No. 110, Organization No. 200, Object Account No. 6010, and Job Order No. 111475, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
