WHEREAS, John is a past Chair of the American Bar
Association's Section on Urban Law and a member of the ABA House

WHEREAS, John is a frequent lecturer on municipal law subjects for Georgetown University, the National College of District Attorneys and the American Bar Association and has authored many published articles for various Law Reviews; and

WHEREAS, John is a contributing editor of <u>Land Use &</u>

<u>Environment Forum</u>, a quarterly publication of the State Bar and the University of California; and

WHEREAS, John served a record three terms as President of the Boys and Girls Clubs of San Diego and as President of the Point Loma Optimist Club and the Downtown Lions Club; and

WHEREAS, the Boys and Girls Clubs presented him with their annual Golden Achievement Award in 1989, the National Council of the Boy Scouts of America designated him a Distinguished Eagle Scout in 1975 and the San Diego County Bar Association presented him with their Outstanding Public Service Award in 1986; and
